Master of Dermatology – Grandfathering information

The Master of Dermatology (MDerm) is closely aligned with the ACD Training Program. As such College recognises that Fellows who wish to complete the MDerm would be eligible for recognition of learning (RPL).

In order to facilitate this, College is granting a Grandfathering/RPL process whereby Fellows who completed their FACD after 2009 will be given automatic exemptions for some subjects and the opportunity to complete or apply for RPL in others, leaving them a small number of subjects to complete the full course.

Those who completed prior to 2009 may also be eligible for grandfathering/RPL. Please contact the College at MADerm@dermcoll.edu.au.
